

GENERAL TERMS AND CONDITIONS OF SALE - TO BE RETURNED DATED AND SIGNED WITHIN 10 DAYS

These terms and conditions set out the booking procedures between the Municipal Campsite Les Treilles and the client booking tourist stays. Booking a stay implies full acceptance of these terms and conditions without reservation. The Municipal Campsite Les Treilles reserves the right to modify its terms of sale at any time.

BOOKING CONDITIONS (Non-smoking rentals)

Bookings are made taking into account the client's preferences as much as possible. Subject to management approval, a booking becomes final after acceptance of the terms of sale, by returning this signed form along with a deposit (25% of the total stay amount, payable by cheque to "Régie Camping Les Treilles", non-refundable except in cases of force majeure with proof provided). Bookings are nominative and non-transferable.

Reservations can be made by post, telephone, or email.

It is recommended to call +33 (0)3 80 92 69 50 or send an email (accueil.camping@montbard.fr) to check availability for the desired dates before proceeding with booking formalities.

No option or reservation will be taken into account without the payment of the deposit within a maximum of 10 days following receipt of this letter (postmark as proof).

A contract will then be sent, which is non-transferable to a third party. This contract must be signed and returned on the day of your arrival.

The balance of the stay is to be paid on the client's arrival at the campsite. The amount due will be calculated based on the arrival and departure dates indicated on the booking form.

The accommodations comply with current campsite legislation. They are intended exclusively for tourism and leisure purposes, meaning that occupation of the accommodation is temporary or seasonal. Tenants must declare that they have a permanent home address. Each tenant must comply with the internal rules posted at reception. Minors must be accompanied by their parents or legal guardians.

RATES, TOURIST TAX, AND INCLUDED SERVICES

The prices indicated on the price lists displayed at reception, on the website, or available upon request are in euros, VAT included. The tourist tax is applied per night, per person over 18 years old. Tourist tax and booking fees are not included in the rental price.

Arrivals are from 4:00 p.m. and departures must be before 10:00 a.m. for rentals. Any late departure will result in an extra night being charged. **In low season, tenants must contact reception no later than the day before to arrange their arrival time.**

Upon arrival, you must register at reception. Any changes affecting the total cost must be reported on the same day. **The prices indicated are valid only for the current year and are revised annually on January 1st.**

You have access to the facilities: reception, bar, games and leisure equipment, tennis court, as well as one free entry per day and per person to the Amphitrite aquatic centre (except for mandatory technical closure periods – variable dates in April and September).

CLEANING

€70 per rental will be charged if the accommodation is not returned in the same clean condition as upon arrival. A vacuum cleaner is available at reception upon request. For early departures outside office hours, a cleaning deposit cheque must be left and will be returned by post to the tenant after inspection, within a maximum of one month.

INVENTORY

An inventory of the premises, furniture, equipment, and kitchen utensils is carried out at each tenant's departure. The tenant **must check the inventory** upon arrival and report any anomalies. A security deposit of €100 per chalet or €185 per mobile home (payable by cheque to the Trésor Public or in cash) will be requested for each rental upon arrival.

This amount will be fully refunded to the tenant on departure if the accommodation and equipment match the inventory upon return of the keys. Any damage, deterioration, or loss will be invoiced and deducted from the deposit based on repair costs. Departure inventories take place between 8:00 a.m. and 10:00 a.m. **The departure time must be arranged upon arrival** with reception staff, and no later than two days before departure. For early departures outside office hours, the deposit will be returned by post within one month after inspection.

MODIFICATIONS AND CANCELLATIONS

It is possible to extend the stay beyond the agreed date with the campsite manager's approval and subject to availability, at the applicable rates. Any interrupted or shortened stay (late arrival, early departure) due to the client will not give rise to a refund (except in cases of force majeure).
