

Rules at the campsite (full version at the reception)

1) Conditions of entry

To be allowed, pitching and staying on the natural area of campsite, it is necessary to have been authorized by the administrator. By law, he/she has to care for good behaviour and order in the campsite, as well as ensuring that the current campsite rules are abided by. This campsite does not cater for permanent campers. Staying on the campsite implies the acceptance of the present regulation and the commitment to conform to it. Particular condition: The access for 6 meter caravans (and/or in double axle) will be submitted to municipal authorization. This campsite does not allow the exercise of a professional activity.

2) Policy

Children under 18 without adult supervision will only be allowed on the campsite with written parental authorization. In application of the article R. 611-35 of the code of entrance and stay for foreigners and asylum's right, visitors will be asked to fill out form staying there full names, dates and place of birth, nationality and current address. Children under 15 can appear on a parent's form. Particular condition : every person wishing to stay in the campsite has to present an ID card to the receptionist and fill out a form which is required by the police. Only dogs and cats will be allowed on campsite grounds and the presentation of a vaccination certificate will be required. A single pet only will be authorized in "Chalets" and Mobil-Homes. No animal is admitted in the bar.

3) Installation

The tent or the caravan and all related equipment must be settled in the place indicated according to the directives given by the administrator.

4) Reception

This campsite opened from March 1st till November 3rd. You shall find at reception all the information on the services of the campsite, the information on the possibilities of reappointment, sports installations, tourist wealth of the neighbourhood and different addresses which can turn out to be useful. A special box intended to receive the complaints is located next the reception area. The complaints will be considered only if they are signed and dated, so please be as precise as possible and relate to relatively recent facts.

5) Posting

The present regulation is posted in the entry of the campsite and to the sanitary facilities. It is given only who on asks.

6) On leaving the campsite

Visitors will be asked to pay for their stay the day before their departure. The payment must be made to the administrator. Please tell reception when you will be leaving ; a precise time will be asked of you.

7) Noise

We ask visitors to avoid unnecessary noise that could bother the people living around then. Please refrain from making any noise after 10 p.m. and before 7 a.m.

8) Visitors

Having been authorized by the administrator, visitors can be allowed on the campsite under the responsibility of the campers who receive them. The campers who receives them can be asked to pay a royalty since their visitor has access to the installations of the campsite. Cars of the visitors are forbidden on the campsite.

9) Traffic and car parking

Inside the campsite, vehicles have to drive to a 10kph maximum speed. Traffic is forbidden between 10pm and 7am. Only the vehicles which belong to the campers can circulate in the campsite. The car park mustn't hinder the traffic nor prevent newcomers' installation.

10) Car parking installations

Each is asked to refrain from any action which could damage the cleanliness, the hygiene, the aspect of the campsite and its installations. It is forbidden to throw waste water on the ground or in trenches. Please empty your waste water in the installations dedicated to for that purpose. All waste must be sorted out and put down in the containers which are allocated to them. Containers for glass, plastic and metal packagings, as well as newspapers are situated near the entry of the campsite. Clothes washing is strictly forbidden except in the tubs foreseen for that purpose. However, it is tolerated till 10am near shelters, on the condition that it is very discreet and does not bother the neighbours. It must not be made from trees. Plantations and floral decorations must be respected or it is forbidden to the campers to plant nails in trees, to cut branches, make plantations. Campers will not be allowed no dig or use personal means of pitch delimitation. Any degradation to the vegetation, fences of the campsite and its installations will be chargeable to the perpetrator. Please leave your your pitch as you find it. Particular condition : if lent anything , campers will held responsible.

11) Dead garage

Campers can leave equipment that is not occupied on the campsite, after agreement of the administrator and only on the indicated place. With surcharge.

12) Infractions

In case a resident would perturb the stay of the other users or would not respect the capacities of the present regulation, the administrator can and will ask retribution, either orally or in writing. If cleaned necessary the administrator can rend a contract void and be allowed to ask you to leave the grounds. If such is the case, the administrator can appeal to the police.

Safety instructions

Fire : open fires or campfires (wood, coal, etc.) are strictly forbidden on the campsite. Camping stoves must be kept clean, in good condition, and can never be used in dangerous situations. In case of fire, please contact management immediately using the cell number given to you at the beginning of this booklet. Fire extinguishers are available to use if necessary, and there is a first aid kit at reception.

Theft : Management is responsible for the items left at reception, as well as they have an obligation to keep an eye out for the safety of the campers. However, the campers are solely responsible for their own installation and belongings, and they are invited to ensure their safety. They also have the duty to inform management of any suspect or activity or person on the campsite.

Games : Any violent or potentially dangerous or upsetting games (e.g noisy) will not be permitted in living areas or pitches, especially if they are occupied, nor will they be allowed in communal rooms (e.g the tv room). Children must be under parental supervision at all times, and management will not take responsibility of any injured or missing child.
